## **Terms of Use Agreement**

Terms of use and responsibility of the administration.

- 1. The registration process implies the user's consent to the processing of his/her data.
- 1.1 It is forbidden to create repeated accounts with the same data (this rule will be effective from 01.05.2024).
- 1.2 The user must keep their personal data (name, phone number, e-mail address) up to date and notify the administration of any changes before 01.05.2024.
- 1.3. In case of using the same data during registration, partners should contact the administration via personal cabinet to correct the accounts for another person.
- 1.4. It is forbidden to transfer access to your account to the curator without prior agreement with the administration.
- 1.5 The user must specify his/her payment data for his/her account only.
- 1.6. The user has the right to temporary support and the obligation to get answers to all questions from the support service.
- 1.7. Administration reserves the right to block the partner in case of fraud or dishonest behavior, as well as for the dissemination of false information about the company.
- 1.8. Administration undertakes to pay its obligations to partners.
- 1.9. Partner is prohibited to disclose his payment data for withdrawal of funds to other accounts, even if they belong to his family, as each account is intended for one person.
- 1.10. The terms and conditions begin to apply from May 1, 2024. The minimum amount for withdrawal is 20 dollars. Commission for withdrawal up to 20 dollars is 2 dollars, and for the amount above 5%. A withdrawal request is processed within 24 hours.
- 1.11. An affiliate is prohibited to use funds not according to the marketing plan and to buy inactive accounts or levels in the company's matrixes.
- 1.12. The Administration has the right to make changes and additions to the terms of the agreement at its discretion at any time.
- 1.13. To participate in the matrix "Sapphire" on the 1st level it is necessary to pay 12\$, and in the matrix "Travel" 9\$. Investments in matrices are prohibited due to the risk of fraud. The company is not responsible for creating inactive accounts.

- 1.14. To participate in the project "Emerald health" Emerald health it is necessary to pay 50\$ (Silver level). After activation the partner receives a unique product from Taiwan. Delivery of the goods to the partner can take up to 60 days.
- 1.15. The company considers applications for trips if there are at least 5 participants from one country.
- 1.16. ST balance is not converted into a regular balance.
- 1.17. Due to the impossibility to change data in the profile, it is recommended that partners carefully check the profile before registration.
- 1.18. The partner is obliged to pay for the visa in case of participation in the trip.
- 1.19. It is impossible to change the sponsor, except if the partner is not yet activated in any of our projects. In this case it is possible to change the referrer.
- 1.20. Changing personal data in the profile is possible only through the support service.
- 1.21. Withdrawal requests are processed within 24 hours on weekdays.
- 1.22. Suspicious transactions may result in the withdrawal requests being canceled.
- 1.23. The amount deposited for activation in matrices is not refundable, as it is used for marketing and payment to other partners.
- 1.24. Now when transferring funds between users, the name and surname of the recipient will be displayed.
- 1.25. Management or founder will not interfere in proceedings between affiliates if they created a strategy to promote in matrices.
- 1.26. The maximum withdrawal amount per day is \$10,000. A withdrawal request can be submitted no more than 1 time per day.
- 1.27. From November 1, 2024 the company will switch to its own cryptocurrency SapCoin.
- 1.28. It is forbidden to poach a partner who was previously registered in someone else's structure. If such actions are detected, the referrer faces a fine of 1000 dollars, and the partner along with all his teams is transferred to the former referrer.
- 1.29 Partners now have the possibility to change their e-mail and phone number independently through their account profile. However, a small fee is required to perform this action. The change of e-mail address is done for a fee. In the profile, there will be a pencil icon next to the e-mail address. When you click on it, the system will ask the user for \$3 to change the address. You can only change your email once within 30 days. After

that, it will be possible to change the address again after 30 days, but the cost of the change will be 6 dollars, and the next time it will be 9 dollars.
